






#### Paragraphs 54 and 55: Linking Services Over Time

#### Paragraph 104

Each year, we report the number of core content provisional teachers and their license:

- 933 Provisional teachers who fit the reporting criteria. Of that, 610 were given reasonable assurance for SY18-19 employment.
- Determinations were made at the time of Probable Organization meetings based on employees' qualifications or demonstration of progress made toward obtaining the appropriate qualification.
- If the employee has not subsequently obtained the SEI endorsement, s/he will be non-renewed in June 2018.
- Among the 164 employees currently not SEI qualified, two employees passed a BPS RETELL course in SY16-17 (indicating that their paperwork is in transition) and 17 employees registered for a BPS RETELL course.





### **Progress Made Over Time**




#### **Data Warehouse**

As part of our ongoing efforts to increase the accuracy of reporting as well as to improve our ability to provide timely ESL and SEI service information to school leaders and other key stakeholders in the district, this report has been generated via a new Data Warehouse process, as opposed to the more manual report generation reports used for previous reporting cycles.











Report shows the level of ESL and SEI services for each EL student per school and is automatically updated daily.

Report provides a dashboard of the level of services for each school.


### Paragraph 94 - School Visits

# Paragraph 32(B) - School Assignment



Consistent with previous reporting, ELs are assigned to their first and second school choices at a higher rate than non-ELs, 52% compared to 31%, and 16% compared to 10% respectively. Furthermore, the rate of Administrative Assignment for ELs is substantially lower than non-ELs, 18% compared to 27%.

#### Paragraphs 72 and 75 - Supporting ELSWD

Paragraph 72 charges the District with maintaining and providing a list of names and contact information for qualified professional bilingual special education evaluators in each of the District's major languages and other languages to the extent available.

#### Paragraph 75

Special Education file review on January 24th:

- Evidence of language and content objectives were found in all settings.
- The classrooms were rich with additional language supports
- Teachers used several different strategies with clear language content
- Teachers demonstrated an awareness of students' different learning styles
- Students seemed comfortable to move about the classrooms, use the materials and resources available and respond in the format most comfortable to them.

Formal classroom observation was held on March 29th:

- Students were supported with clearly posted content and language objectives according to levels, vocabulary charts differentiated by levels, varied writing supports, written materials differentiated by levels and scaffolded by modeling or demonstrating, and connecting prior knowledge
- The lesson was appropriately scaffolded; the teacher differentiated to meet the individual needs of each student per their IEP.




#### Improvements to services:
